

### TERMS & CONDITIONS

- 1) A limit of 1 artwork per artist can be submitted.
- 2) Original 2D artworks must not be larger than 70cm x 70cm including frame. Framing must occur prior to submission.
- 3) Artwork must be ready for display. 2D framed artwork must be ready to hang with 'D' hooks and wire installed. Artwork received that is not ready to hang will not be accepted.
- 4) Original 3D artworks must not be larger than 70cm x 70cm x 70cm.
- 5) Artwork listed as "Not For Sale" will be ineligible to win the artX Prize.
- 6) Original artworks must be clearly marked on the reverse with the artist's name, artwork title and price. If artwork is larger than size restrictions it will be ineligible to win the artX Prize.
- 7) Artwork must be delivered to Wyndham Park House, 53a Kookaburra Avenue, Werribee by 13<sup>th</sup> July to be included in the exhibition.
- 8) genU will take on the role of agent for the purpose of selling exhibited artwork during the exhibition.
- 9) You will receive 75% of the proceeds of sale of your artwork.
- 10) You agree to genU receiving the remaining 25% of the sale proceeds ("the commission"). After the commission has been deducted from the sale price, the balance of the proceeds of sale will be deposited into your bank account (details to be provided with entry form).
- 11) Should you not provide your bank account details on your entry form and your artwork is sold during the exhibition. Payment of the sale proceeds will not occur until bank account details are provided.
- 12) In entering your artwork, you give genU the following rights:
  - a) To show your artwork at artX Wyndham
  - b) To use an image of your artwork in the Catalogue and other Promotional Material
  - c) To use your personal information (including name, image and artwork) in promotional and other publications at any time in the future
- 13) genU will exercise all due care with the artworks submitted, but will not be liable for any loss or damage suffered to any artwork under their control.
- 14) As the artist, you indemnify genU and their agents against all loss or damage suffered by you in relation to your artwork.
- 15) You will arrange your own insurance cover to protect the artwork from loss and damage while it is in transit, while it is in the custody of Karingal St Laurence and for the duration of the exhibition.
- 16) The judges' decision is final on all aspects of awarding the prizes, and no correspondence or appeal will be entered into or considered.
- 17) artX undertakes to do the following:
  - a) To invite you to the official winner announcement and exhibition launch
  - b) To make unsold artwork available to the artist, for collection after the conclusion of the exhibition at Wyndham Park House.
  - c) To announce the winners and award prizes at an official event.
